### GOVERNMENT ORDER

#### Sub: Piloting of Electronic Government Procurement System ( e-GP)

On 21 June 2017, the Royal Government of Bhutan has launched the Phase I of Electronic Government Procurement (e-GP) system with the objectives to ensure transparency, effectiveness, accountability and efficacy of the procurement process for the procurement of Goods, Works and Services.

The Government hereby direct to pilot the e-GP system in four agencies namely Ministry of Finance, Ministry of Works and Human Settlement, Ministry of Education and Samdrup Jongkhar Dzongkhag. In order to ensure successful piloting of the e-GP, the following directives are initiated from the Government henceforth:

- i. All pilot Procuring Agencies to register in the e-GP system through Government Procurement and Property Management Division (GPPMD). The Agencies must provide the details of one dedicated Procuring Agency Administrator by 19<sup>th</sup> July, 2017.
- ii. All the Bidders (Contractors, Suppliers and Consultants) must register in the e-GP system by 25<sup>th</sup> July, 2017. All the registered bidders will be provided training by the GPPMD.
- iii. The conduct of procurement through e-GP system shall be guided by e-GP Guidelines.
- iv. All procurement shall be carried out using the e-GP System for these pilot agencies.
- v. All registration, tender fees, downloading, submission shall be free until further notice.
- vi. The Financial Institutions shall facilitate any transactions related to procurement.

This Government Order shall come into force with immediate effect.
