**Subject: Procurement Rules and Regulations 2023 and SBDs (Amendment)**

This is to notify that pursuant to the procurement reform notification via notification No. MOF/FS-04/23-24/DPP/3 dated June 29, 2023, the Standard Bidding Document (SBD) for Procurement of Works (Above Nu. 5 million) and the Standard Bidding Document (SBD) for Procurement of Goods (Above Nu. 0.500 million) are hereby amended as follows:
